

The undersigned, desiring to form a corporation for the purpose hereinafter stated under and pursuant to the laws of the State of Florida, and in accordance with Florida Statutes §621, do hereby declare as follows:

ARTICLE I

NAME

The name of the corporation shall be R. R. ALCALDE, M.D., P.A.  
The nature of the business is the practice of medicine.

ARTICLE II

BUSINESS AND PURPOSE



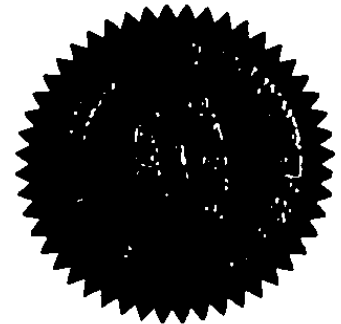
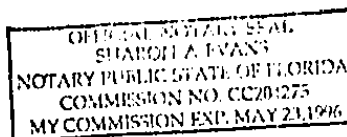
