**ARTICLES OF INCORPORATION  
OF THE  
SHEPHERD ASSOCIATES, INC.  
A FLORIDA CORPORATION**

**ARTICLE ONE:** The name of the corporation is Shepherd Associates, Incorporated.

**ARTICLE TWO:** The period of its duration is perpetual.

**ARTICLE THREE:** The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

**ARTICLE FOUR:** The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares of no par value.

**ARTICLE FIVE:** The corporation will not commence business until it has received, for the issuance of shares, consideration of their value of \$1,000 or more consisting of money, labor done, or property actually received.
