ARTICLES OF INCOPPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, to hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is S & K WATERPROOFING, INC.

ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is April 20, 1995.

ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To engage in the business of waterproofing and exterior building maintenance.
- To transact any other lawful business for which a corporation may be formed and allowed to do under the Florida General Corporation Act.
