The undersigned subscriber to these Articles of Incorporation,
natural persons competent to contract, hereby subscribe to and
form a corporation for profit under the laws of the State of Florida.

ARTICLE I

(Name)

1.01 The name of the corporation is *Chris P. G., Inc.*

ARTICLE II

(Nature of Business)

2.01 The corporation may engage in any activity or business that is permitted under
the laws of The United States of America and of this State.

ARTICLE III

(Capital Stock)

3.01 The maximum number of shares of stock that this corporation is authorized to
have outstanding at one time is *One Hundred (100)* shares of common stock having nominal
or par value of *One Dollar (\$1.00)* per share. Said stock shall be payable in cash, property,
labor, or services at a just valuation to be fixed by the stockholders at a meeting called for
that purpose.

ARTICLE IV

(Capital)

4.01 The amount of capital with which this corporation shall begin is *One Hundred Dollars (\$100.00)*.

ARTICLE V

(Corporate Existence)

5.01 Commencement - The date when corporate existence shall commence shall be *April 21, 1995*.

5.02 Duration - This corporation shall exist perpetually until dissolved according to law.

(Principal Office)

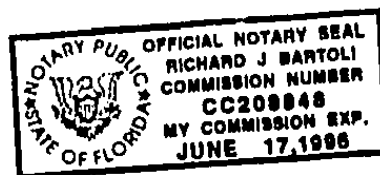
