



INDEMNIFICATION

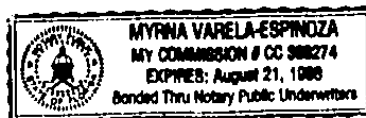


