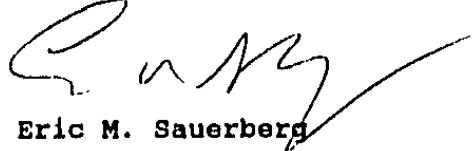

**ARTICLES OF INCORPORATION
OF
GEORGE G. LEVY, M.D., P.A.**

The undersigned, for the purpose of forming a corporation under the Florida Professional Corporation Act, Florida Statutes §621.01, et seq., hereby adopt the following Articles of Incorporation:

ARTICLE ONE

1.01 The name of this corporation is GEORGE G. LEVY, M.D., P.A.

ARTICLE TWO

2.01 The corporation is to have perpetual existence.

ARTICLE THREE

3.01 The purpose for which the corporation is organized is to practice medicine. Further, the corporation shall have all powers permitted to a corporation under the Florida General Corporation Act as extended to a Florida Professional Service Corporation under Florida Statute §621.13.

ARTICLE FOUR

4.01 The aggregate number of shares which the corporation shall have the authority to issue is 1,000, all of which shall be common shares with a par value of \$1.00 per share.

ARTICLE FIVE

5.01 The street address of the initial corporate office of the corporation is 7171 N. University Drive, #200, Tamarac, Florida 33321.

5.02 The name and address of the initial Registered Agent for this corporation to accept service of process within the State of Florida is GEORGE G. LEVY, M.D., 7171 N. University Drive, #200, Tamarac, Florida 33321.

ARTICLE SIX

6.01 The name and address of the incorporator of this corporation is GEORGE G. LEVY, M.D., 7171 N. University Drive, #200, Tamarac, Florida 33321.

6.02 Said incorporator is over the age of eighteen (18) years; is sui juris, and is a citizen of the United States.

ARTICLE SEVEN

7.01 One (1) director shall constitute the initial Board of Directors of the corporation, but the Bylaws may provide for such increase or decrease in number thereof as is authorized by law.

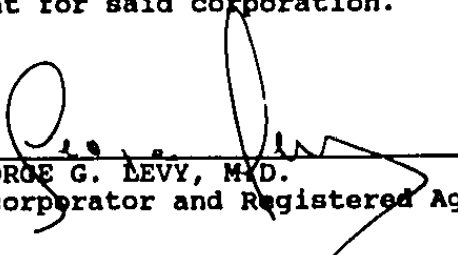
ARTICLE EIGHT

ARTICLE NINE

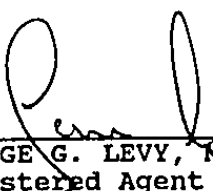
9.01 The effective date of this corporation shall be April 13th, 1995, which is the date of execution hereof.
