ARTICLES OF INCORPORATION

We the undersigned, do hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be: NO QUESTION IMPORTS OF OKEECHOBEE, INC.

ARTICLE II

The principal place of business of said corporation shall be in Okeechobee County, Florida, with the privilege of having branch offices at other places within the State of Florida, and within or without the United States of America, the post office address of said corporation being 2675 S.W. 24th Ave., Okeechobee, Florida 34974.

ARTICLE III

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all things hereinafter mentioned as freely and to the same extent as natural person might or could do, to-wit:

To engage in various enterprises for profit, including the importation of goods and items into this Country for wholesale and retail sales; transactions with foreign and international governments, brokers, agents and entities to procure goods and services necessary to conduct said business; and such other

transactions with local agencies, business's, governments or other regulatory entity as may be necessary to conduct the business; to lend or borrow money, goods or services; to employ agents, employees or independent contractors; and also, any and all such additional functions reasonably calculated as necessary to carry on the general nature of the business.

ARTICLE IV

The amount of capital stock of this corporation shall be one hundred (100) authorized shares of \$1.00 par value.

ARTICLE V

This corporation shall have perpetual existence unless dissolved by the stockholders, or the State of Florida.

ARTICLE VI

The number of Directors of this corporation shall be not less than two (2) unless otherwise changed by the By-Laws. The manner of election of the directors and officers shall be as stated in the by-laws, or by majority vote of all shareholders at the annual meeting of the Corporation if not otherwise set forth.


ARTICLE IX


