ARTICLES OF INCORPORATION OF

RICH'S NATIONAL INC.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE: RICH'S NATIONAL INC..

ARTICLE II

THE CORPORATION WILL ENGAGE IN ANY ACTIVITY PERMITTED BY THE LAWS OF THE STATE OF FLORIDA AND THE UNITED STATES OF AMERICA.
