## Article I

Name. The name of this Corporation is THE SOFT SWAP, INC.

#### Article II

Principal Office. The address of the principal office of the Corporation is 3100 S.W. 35th Place, Suite 11-E, Gainesville, FL 32608.

### Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles,

#### Article IV

Purpose.
