The name of this corporation is Richindy Corporation. Its principal place of business is 3855 Tamiami Trail, Punta Gorda, Florida 33950, and its mailing address is 25191 Olympia Avenue, Punta Gorda, Florida 33950.

**ARTICLE II.**

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.

**ARTICLE III.**

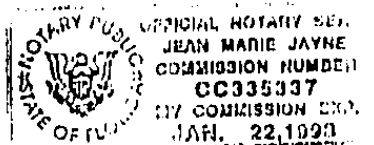

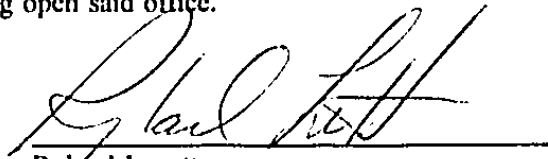
