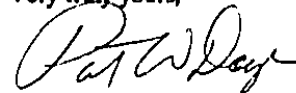

ARTICLE 1 - Name

The name of the corporation is DAMP, INC.

ARTICLE 2 - Address

The street address of the initial principal office of the corporation is 8445 International Drive, Suite 108, Orlando, Florida 32819. The mailing address of the corporation is the same.

ARTICLE 3 - Shares

This corporation is authorized to issue 2000 shares of \$1.00 par value common shares. All issued shares must be represented by certificates.

ARTICLE 4 - Preemptive Rights

Each shareholder, upon the sale for money of any new shares of this corporation of the same class or series as that which the shareholder already holds, shall have the right to purchase a pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE 5 - Initial Registered Office and Agent

The street address of the corporation's initial registered office is 800 West Morse Boulevard, Suite 1, Winter Park, Florida 32789 and the name of the initial registered agent at that office is Patrick W. Doyle. The written acceptance by the registered agent is attached.

Corporate existence begins on the date of signing of the Articles of Incorporation by the incorporator provided the Articles are filed by the Department of State within five (5) business days after such date; otherwise, the date of corporate existence shall begin on the date the Articles are filed by the Department of State.

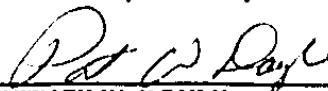
