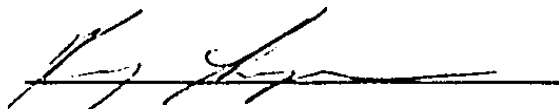

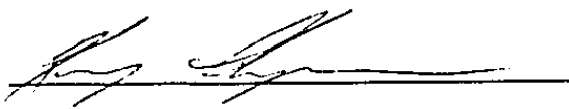

**FIRST:** To amend **ARTICLE 1 - NAME**, from Exposure Communications, Inc. to **B-Kleen, Inc.**

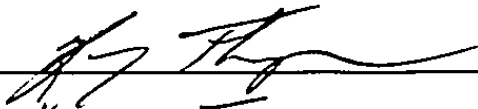
