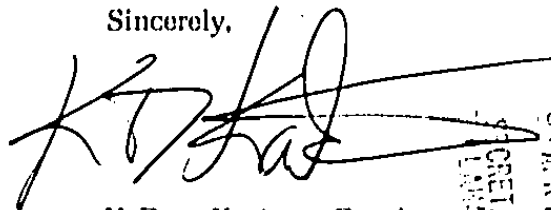

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I**

**Name of Corporation**

The name of this corporation shall be Black Tie Janitorial Services, Inc.

**ARTICLE II**

**Nature of Business**

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States of America and this State.

**ARTICLE III**

**Capital Stock**

The maximum number of shares the corporation is authorized to have outstanding at any one time is: 100 shares of \$1.00 Dollar par value all of which shall have the same rights and privileges.

**ARTICLE IV**

**Initial Capital**
