In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is

DIACTIVE CORPORATION

ARTICLE II

The existence of the Corporation shall begin on APRIL 18 1995.

ARTICLE III

The address of the principal office of the Corporation is:

The maximum number of shares this Corporation is authorized to issue is 100 shares, all of which shall be Common Shares. ARTICLE VII



The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.




