Article I

Name. The name of this Corporation is **T & S BINDERY, INC.**

Article II

Initial Registered Office and Agent. The street address of the initial registered office of this Corporation is 303 State Road 26, Melrose, Alachua County, Florida, 32666 and the name of the initial registered agent of this Corporation is **JOHN D. MIDDLETON, ESQUIRE, MIDDLETON, PRUGH & EDMONDS, P.A.**

Article III

Capital Stock. This Corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock. All shareholders shall have preemptive rights in future stock sales by the corporation.

Article IV

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.
