The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract, hereby files these Articles of incorporation to form a corporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I - NAME

The name of this Corporation is :

ARTICLE II - PURPOSE

This Corporation is organized for the following purpose:

To buy, and sell furnishings and offer design services for the purpose of conducting any and all lawful business.

ARTICLE III - DURATION

This Corporation is to exist perpetually.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue ONE THOUSAND (1,000) shares of One and No/100 Dollars (\$1.00) par value common stock.

#### ARTICLE V - BOARD OF DIRECTORS


The Corporation shall have the further right and power to:


