OFFICE 1

The name of the corporation is A.M. OFFICE, INC.

OFFICE 2

The Corporation may engage in any and all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes. After pursuing its purposes, the Corporation may exercise the powers granted now or in the future by section 607.0702, Florida Statutes, and by common law.

SHARES 1

The aggregate number of shares which the Corporation shall have the authority to issue shall be 50,000,000 of common stock. Each of such shares shall have a par value of \$1.00 per share.


