# Articles of Incorporation of

## ARTICLE ONE

The name of the corporation is HEALTH RENOVATIONS, INC. The principal address of the corporation is: 17364 Boca Club Blvd, #508, Boca Raton, FL 33487.

## ARTICLE TWO

The period of its duration is perpetual.

#### ARTICLE EIGHT

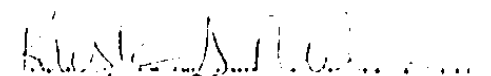
The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
