ARTICLES OF INCORPORATION

OF.

PRO - MEDICAL CONSULTANTS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I: NAME OF THE CORPORATION

The name of the corporation is PRO - MEDICAL CONSULTANTS, INC., hereinafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation is at 1621 N.W. 13th COURT, MIAMI, Florida 33125.

ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpettal unless dissolved according to law.

ARTICLE IV: PURPOSE OF THE CORPORATION
