

The undersigned, being individuals, do hereby act as incorporators in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is The NEXUS Group, P.A.

SECOND: The mailing address, wherever located, of the principal office of the corporation, if known, is 4800 MADISON STREET, HOLLYWOOD, FL 33021.

FOURTH: The number of shares that the corporation is authorized to issue is 20, all at \$ 1.00 par value and are of the same class and are to be Common shares.

FIFTH: The street address of the initial registered office of the corporation in the State of Florida is 2221 CYPRESS ISLAND DRIVE, BUILDING 61, APT. 304, POMPANO BEACH, FL 33062.

The name of the initial registered agent of the corporation at the said registered office is JULIA GROSS.

TENTH: Whenever the corporation shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act.




