Article I

Name Of Corporation

The general nature of the business to be transacted by this corporation is Health Care Consulting, as well as any other activities of business permitted under the laws of the United States and the State of Florida.

### **Commencement Of Corporate Existence**

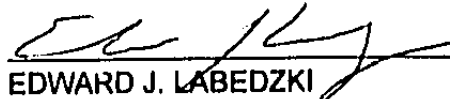
The date that corporate existence shall begin shall be the date of the filing of these Articles of Incorporation with the State of Florida.
