ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- A.R.T. HEATING AND AIR CONDITIONING, INC.
and whose principal office location is 8190 57TH ST NORTH

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:
HVAC-SALES, SERVICE, AND INSTALLATION and shall include the
transaction of any and all lawful business for which corporations may be
incorporated under State of Florida Statutes.

ARTICLE IV - CAPITAL STOCK
