The undersigned subscriber to these Articles of Incorporation, natural persons competent to contract, hereby organize and incorporate a corporation under the laws of the State of Florids.

ARTICLE_I NAME

The name of the corporation is: MAYO INTERNATIONAL CORPORATION.

The corporation will engage in any activity of business permitted under the laws of the United States or of this State.
