**Article I.** The name of this Corporation is: **BEAN 2, INC.**

**Article II.** This Corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation by the Florida Secretary of State.

**Article III.** This Corporation may engage in any lawful business activity permitted under the General Corporation Act of the State of Florida.

**Article IV.** This Corporation is authorized to issue Ten Thousand (10,000) shares of Capital Stock, all of which shall be designated as "Common Stock"; with each such share having the par value of \$1.00, and each being entitled to one vote in all matters submitted to the Shareholders.


