OF

**ARTICLE I**

**ARTICLE II**

**DURATION**

This Corporation shall have perpetual existence.

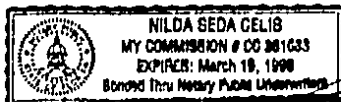
