ARTICLES OF INCORPORATION
OF

ARTICLE I
CORPORATE NAME

The name of this corporation is SALON CENTRAL, INC.

ARTICLE II
NATURE OF BUSINESS AND POWERS

The nature of the business to be transacted by this corporation is hair, nail and other related services, and any and all business permitted under the laws of the State of Florida.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is two hundred (200) shares of common stock having no par value.

ARTICLE IV
TERM OF EXISTENCE

This Corporation shall have perpetual existence commencing upon the filing of these Articles.
