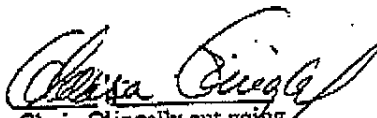

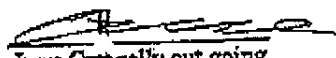

The buyer will pay for the above purchase in one payment, with separate receipt at the signing of this agreement.

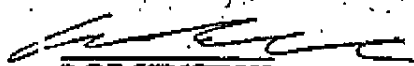

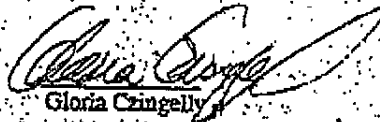
