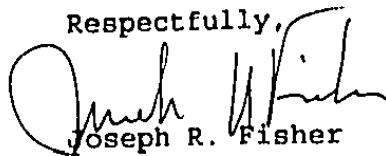

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation shall be Digital Consulting, Inc. and the address of this corporation is 2300 E. Ocean Boulevard, Stuart, Florida 34996.

ARTICLE II.

DURATION

This corporation shall have perpetual existence.

PURPOSE
