The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of the Corporation is:  
Attorney Communication Skills Incorporated
2. The period of its duration is perpetual.
3. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. The corporation shall have authority to issue 500 shares, all of one class, \$.01 par value.
5. The address of its principal place of business is 404 Sable Court, Tallahassee, Florida 32304.
6. The initial registered agent of the corporation is James Robert Brey 404 Sable Court, Tallahassee, Florida 32304.
7. The number of directors constituting its initial board of directors is one (1). The names and addresses of the officers and directors of this Corporation, who shall hold office for the first corporate year or until their successors are chosen are:

8. The name and address of the incorporator is James Robert Brey, 404 Sable Court, Tallahassee, Florida 32304.
9. Preemptive Rights shall be as follows: The holders of the common stock of this corporation shall have preemptive rights

to purchase, at prices, terms and conditions that shall be fixed by the Shareholders, such of the shares of the stock of this corporation as may be issued for money (money, or any property or services) from time to time, in addition to that stock authorized (and issued) by the corporation. The preemptive right of any holder is determined by the ratio of the authorized (and issued) shares of common stock held by the holder to all shares of common stock currently authorized (and issued).

10. Where shareholder approval is required for any action, each shareholder shall be entitled to vote equal to the number of shares he or she may own. The approval of any action shall require the affirmative vote of not less than fifty-one percent (51%) of all of the issued and outstanding shares.

11. The business and affairs of the Corporation shall be managed by the shareholders and the Board of Directors.

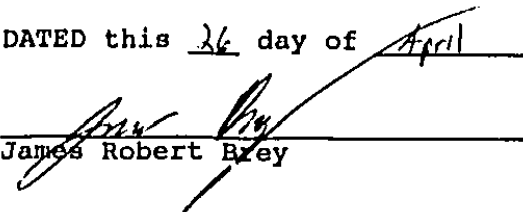
