ARTICLES OF INCORPORATION

OF

EILEEN CORSE, INC.

ARTICLE I. NAME

The name of this corporation is: Eileen Corse, Inc.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

Court Reporting and the lease or purchase of such real and personal property as is ancillary to the rendering of such professional services.

To invest funds in real estate, mortgages, stocks, bonds, or any other type of investment;

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required;

To purchase the corporate asset of, merge or consolidate with any other domestic corporation engaged in the same character of business;

To redeem, purchase, retain, sell and transfer its own capital stock;

To create employee benefit plans and trusts incidental thereto; and

ARTICLE III. CAPITAL STOCK
