The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is BLACKBIRD MOBILE CAR CARE, INC. with its mailing address and principal office at 514 Sabal Trail, Longwood, Florida 32779.

**ARTICLE II
DURATION**

The term of existence of this corporation is perpetual beginning the date of filing.

**ARTICLE III
