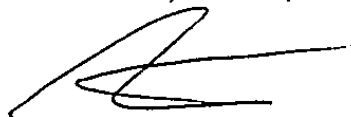

Article I - Name

The name of the corporation is: Corbin and Associates, Inc.

Article II - Duration

This corporation shall exist perpetually.

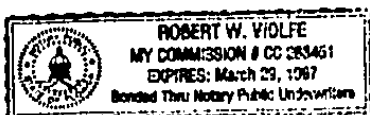
