# ARTICLES OF INCORPORATION OF W.F. MACK, INC.

#### ARTICLE I - NAME

The name of this corporation is W.F. MACK, INC.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing upon the filing of the Articles of Incorporation with the Secretary of the State of Florida.

#### ARTICLE III - PURPOSE

#### ARTICLE X - BY-LAWS
