ARTICLES OF INCORPORATION OF  
JACK CARAVELLO HOMES INC

Article I - Name

The name of this corporation is Jack Caravello Homes Inc.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

The purpose of this corporation shall be to engage in the business of residential and commercial construction and to transact or engage in any lawful business not prohibited by the laws of the State of Florida or the United States of America.

Article IV - Capital Stock

This corporation is authorized to issue 7,500 shares of one dollar (\$1.00) per share par value common stock.

Article V - Pre Emptive Rights

Every shareholder, upon the sale for cash of any new stock, including all common stock shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

Article VI - Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 5990 Gillott Blvd., Port Charlotte, Fl. 33981 and the name of the initial registered agent of this corporation at that address is Jack Caravello.

Article VII - Initial Board of Directors
