



MANAGEMENT OF CORPORATION BY DIRECTORS AND OFFICERS



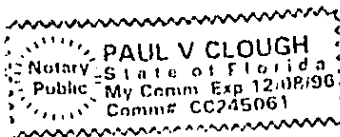
