- First: The name of the corporation is Informative Solutions, Inc.
- Second: It's registered office in the State of Florida is to be located at 8731 Osage Drive, Tampa, Florida 33634 in the County of Hillsborough. The registered agent in charge there of is Vickie A. Campbell. This is also to be the principal address and office for the corporation.
- Third: The period of duration is perpetual.
- Fourth: The nature of the business is to transact, promote, or engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.
- Fifth: The amount of total authorized capital stock of the corporation is to be divided into two hundred thousand (200,000) common shares of one dollar (\$1.00) par value.

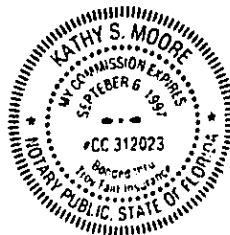
