ARTICLES OF INCORPORATION

OF

ABSOLUTE ACCOMMODATIONS, INC.

The undersigned, acting as Incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation for secon corporation:

ARTICLE I

The name of this corporation is ABSOLUTE ACCOMMODATIONS, INC.

ARTICLE II DURATION

This corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually unless dissolved by operation of law.

ARTICLE III GENERAL PURPOSE
