The undersigned incorporator hereby forms a corporation under Chapter 607, Florida Statutes.

ARTICLE I

NAME

The name of the corporation is VIP LAWN CARE, INC., and its principal place of business is 1491 Spring Lake Road, Fruitland Park, Florida 34731, and a mailing address of P. O. Box 445, Fruitland Park, Florida 34731.

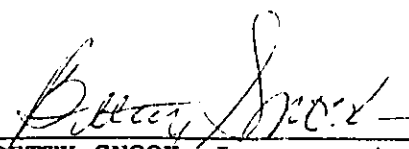

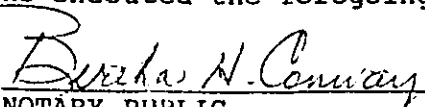
