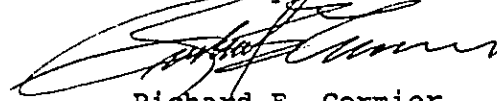

ARTICLES OF INCORPORATION
OF
REC ASSOCIATES, INC.

The undersigned incorporator to these Articles of Incorporation hereby forms a corporation (the "Corporation") under the laws of the State of Florida as follows:

ARTICLE I
Name

The name of the Corporation is REC ASSOCIATES, Inc.

ARTICLE II
Term of Existence

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation by the office of the Florida Department of State, and the Corporation shall have perpetual existence thereafter.

ARTICLE III
Nature of Business

The Corporation is organized to engage in any lawful act or activity for which corporations may be organized under the Florida Statutes.

ARTICLE IV
Capital Stock

The Corporation is authorized to issue ten (10) shares of \$10.00 par value common stock, which shall be designated common shares.

The power to adopt, alter, amend, or repeal bylaws shall be vested in the board of directors of the Corporation.

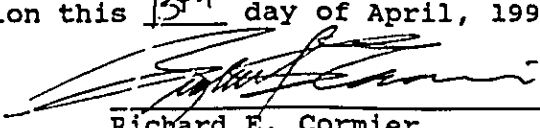
ARTICLE IX

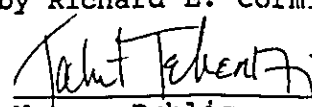

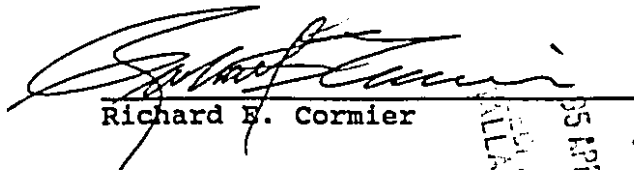
