## ARTICLES OF INCORPORATION OF DISTINCTIVE CONTRACTOR SERVICES, INC.

ARTICLE I. NAME AND ADDRESS: The name of the corporation is DISTINCTIVE CONTRACTOR SERVICES, INC., and it's principal office and mailing address is 1111 Lincoln Road, Suite 325, Miami Beach, Florida 33139.

ARTICLE II. REGISTERED OFFICE AND AGENT: The Registered Agent is ARNOLD M. WEINER, ESQUIRE, and the initial registered office of the Corporation is 1111 Lincoln Road, Suite 325, Miami Beach, Florida 33139.

ARTICLE III. TERMS OF CORPORATE EXISTENCE: The Corporation shall exist in perpetuity unless dissolved according to law and such existence shall commence at the time of the filing of these Articles of Incorporation by the Secretary of State of the State of Florida.

ARTICLE IV. PERMITTED ACTIVITY: The Corporation may engage in any activity of business permitted under the laws of the United States and of the State of Florida.

ARTICLE V. AUTHORIZED SHARES: The total number of shares which the Corporation is authorized to issue shall be one thousand (1,000) shares of common voting stock without par value.

ARTICLE VI. PRE-EMPTIVE RIGHTS DENIED: No holder of any shares of the Corporation shall have any pre-emptive right to purchase, subscribe for or otherwise acquire any shares of the Corporation of any class now or hereafter authorized, or any securities, exchangeable for or convertible into such shares, or any warrants or any instruments evidencing rights or options to subscribe for, purchase, or otherwise acquire such shares.

ARTICLE VII. DIRECTORS: The business of the Corporation shall be managed by a Board of Directors, consisting of not fewer than one person, the exact number to be determined, from time to time, in accordance with the By-Laws of the Corporation.

ARTICLE VIII. INCORPORATORS: The name and address of the Incorporator is: Arnold M. Weiner, Esq., Law Offices of Arnold M. Weiner, 1111 Lincoln Road, Suite 325, Miami Beach, Florida 33139.

ARTICLE IX. INDEMNIFICATION: Every person now or hereafter serving as Director, officer of employee of the Corporation shall be indemnified and held harmless by the Corporation from and against any and all loss, cost, liability and expense that may be imposed upon or incurred by him in connection with or resulting from any claim, action, suit or proceeding, in which he may become involved, as a party or otherwise, by reason of his being or having been a Director, Officer of Employee of the Corporation, whether or not he continues to be such at the time such loss, cost, liability or expense shall have been imposed or incurred, except with regard to matters as to which any Director, Officer of Employee shall be adjudged in any claim, action, suit or proceeding to be liable for his own gross negligence or willful misconduct in the performance of his duty. Expenses (including attorneys' fees) incurred in defending any claim, action, suit or proceeding may be paid by the Corporation in advance of the final disposition of such a proceeding.
