Tampa, Florida 33609.




ARTICLE IX. AMENDMENT

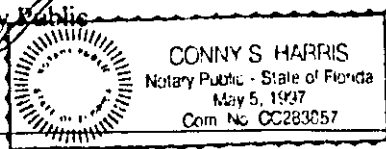
