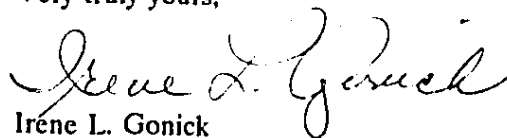

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is: D&D FOOD BROKERS INTERNATIONAL, INC.

**ARTICLE II**

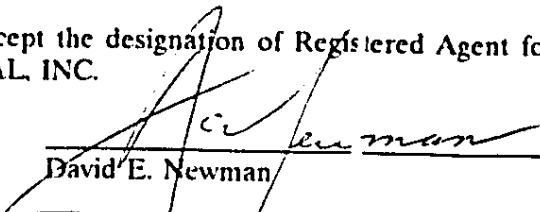

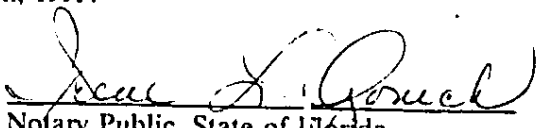
