ARTICLES OF INCORPORATION OF PLAYERS INTERNATIONAL CONSORTIUM INC

ARTICLE I NAME/LOCATION

The name of this corporation is PLAYERS INTERNATIONAL CONSORTIUM INC. The Principal Office of the corporation is 5415 Lake Howell Road, Suite 231, Winter Park, Florida, 32792.

ARTICLE 2 DURATION

The period of duration of this corporation is perpetual.

ARTICLE 3 PURPOSES AND POWERS
