AMENDMENTS



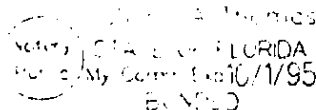


