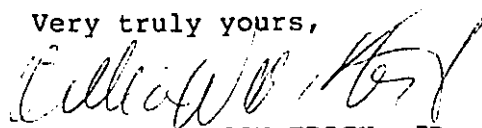

ARTICLE I: CORPORATE NAME

The name of this corporation is: VWK, INC.

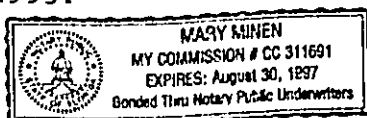
