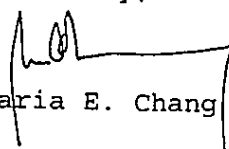

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is "BUILDTech CORP."

ARTICLE II

The principal office and mailing address of this corporation is 1825 Ponce de Leon Blvd., Suite 354, Coral Gables, Florida 33134.

ARTICLE III

The duration of this corporation is to be perpetual.

ARTICLE IV

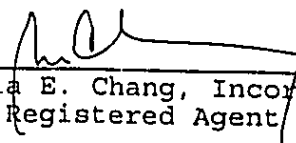
ARTICLE X

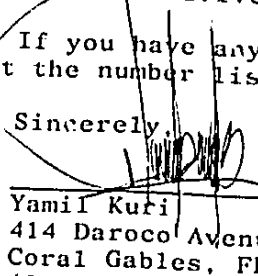
