To lend money to, and accept credit to assist, its officers and employees in accordance with Florida Statute, Chapter 687;

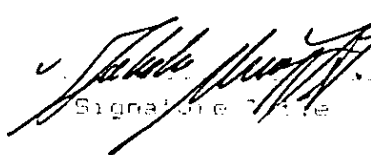
