THE UNDERSIGNED, being over the age of eighteen years, in order to form a corporation pursuant to the provisions of the Corporate Code, hereby certifies as follows:

**ARTICLE I
IDENTIFICATION**

The name of the corporation, hereinafter referred to as the "Corporation" is **SunCoast Technical Sales, Inc.**

**ARTICLE II
PERIOD OF EXISTENCE**

The period during which the corporation shall continue is perpetual.

**ARTICLE III
REGISTERED OFFICE AND REGISTERED AGENT**

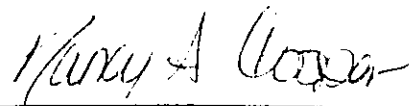
