The undersigned hereby adopts the following Articles of Incorporation for the Appurpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - Name

The name of the corporation is UNIQUE VALET PARKING SERVICES, INC.

ARTICLE II - Commencement of Existence and Duration

This corporation is to commence its corporate existence on April 21, 1995 pursuant to Fla. Stat. §607.167 and shall exist perpetually thereafter until dissolved sooner according to law.
