ARTICLE I

NAME

The name of this corporation is: Clinda Resources, Inc.

ARTICLE II

PURPOSE

1. To conduct general business related to the publishing of books, newspapers, and newsletters. To include, but not limited to, the buying and selling of products and services related to these fields.
2. To engage in real estate investments; to include: buying, renting and selling of properties. To include all other activities related to the aforementioned.
3. To keep, examine, inspect, prepare balance sheets, and audit the books and accounts of others; to devise and install financial, accounting, checking, correspondence, filing and other office and business systems; to compile statistics as an aid to individuals and/or companies in the making of reports and statements required by tax laws; to provide bookkeeping services to the general public.
4. To provide secretarial, stenographic, photo copying

and direct mail services to the general public.

5. To purchase, buy, sell, and exchange office equipment and machinery; and to do all things incidental to the accomplishment of the foregoing purposes.

6. To engage in any activity or business permitted under the laws of the United States and the State of Florida.

### ARTICLE III

#### CAPITAL STOCK

This corporation is authorized to issue 100,000 shares of common stock.

The common stock of this corporation shall have the following characteristics:

- (a) Par value shall be \$0.10 per share.
- (b) At all meeting of the stockholders the common stockholders shall be entitled to cast (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him in voting thereon.
- (c) Except as otherwise provided by law, the entire power for the election of directors and for all other purposes shall be vested exclusively in the

holders of the common stock.

- (d) Preemptive rights shall attach to all shares of common stock.

#### ARTICLE IV

##### TERM OF EXISTENCE

This corporation shall be perpetual existence commencing on this 24<sup>th</sup> day of April, 1995.

#### ARTICLE V

##### INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 12685 Timber Pine Trail, Wellington, Florida 33414 and the name of the initial registered agent of this corporation is Clinton M. Beckwith. The Board of Directors may, from time to time, change the street address and post office address of the corporation as well as the location of its principal office.

#### ARTICLE VI

##### INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially.

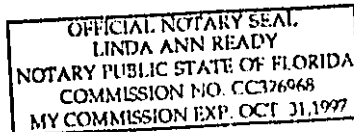
